- Create a plan that addresses your plan to include the following:
 - Detailed overview of what you are going to do.
 - The Total cost of the project and the time frame it will be completed.
 - A system for tracking results of this effort. i.e. how will you determine whether your effort has been successful?
 - A signature from the person responsible for executing your plan.
- An accountability report is due to the IdTA on or before January 15, 2026. Failure to provide a report or failure to use the grant for the requested purpose will jeopardize your eligibility for a grant in the future.

By completing and signing this form, the Organization Member agrees to provide the IdTA a final report by **January 15, 2026**. We also recognize that being held accountable for the funds we receive by reporting our results and best practices will improve our chances for additional funding in the future.
